OMER PRIVACY NOTICE ON THE PROCESSING OF PERSONAL DATA

1.Purpose of Processing Your Personal Data

Your collected personal data, in accordance with the basic principles stipulated in the Law and in accordance with the personal data processing conditions specified in Articles 5 and 6 of the Law, to carry out the necessary studies and to carry out the relevant business processes, within the scope of performing the necessary studies and executing the related processes to inform the people who request information about the products and services, fulfilling our obligations regarding the legal, contractual or internal and external procedures to which we are subject, and responding to requests from legally binding and authorized public or private institutions and for the following purposes. ("Purposes") can be processed.

- Management of customer relations and conducting corporate communication activities,
- evaluation and finalization of requests and complaints,
- Execution of accounting and financial processes,

2. Parties that Your Personal Data is Transferred and Transfer Purposes

Your collected personal data may be transferred to our shareholders, business partners, legally authorized public institutions and legally authorized private persons in accordance with the above-mentioned Purposes in accordance with the personal data processing conditions specified in Articles 8 and 9 of the Law.

3. Collection Method and Legal Reason of Your Personal Data

In case of contact our company, your personal data is collected from electronic and physical media through physical and online forms, telephone, open internet resources, e-mail and website channels. In addition, your personal data is collected on the basis of legal reasons for the explicit consent, in case of the contract established and executed in Articles 5 and 6 of the Law is found and executed by legitimate interests.

4.Your Rights as Data Subjects Indicated Under Article 11 of the Law

As personal data subjects, you are entitled to the following rights under Article 11 of the Law:

- To learn whether your personal data are being processed,
- To request information if your personal data have been processed,
- To learn the purpose of the processing of your personal data and whether they have been used accordingly,
- To learn which third parties domestic or abroad your personal data has been transferred to,

- To request rectification in case your personal data has been processed incompletely or inaccurately,
- To request erasure or destruction of your personal data under the conditions specified in the relevant legislation,
- To demand the erasure or annihilation of personal data in case the reasons necessitating the processing have disappeared even though it was processed in accordance with the Law and other relevant provisions and to demand the operations in this regard be reported to third parties your personal data has been transferred to,
- To object the occurrence of any consequence that is to your detriment by means of analysis of personal data solely through automated systems,
- To demand compensation for the damages that you have suffered as a result of an unlawful processing of your personal data.
